RELEASE & WAIVER OF LIABILITY FORM

IN CONSIDERATION FOR ME BEING ABLE TO PARTICIPATE IN ALL COMPETITIONS, EVENTS & ACTIVITIES RUN BY THE INGLEWOOD SHOW SOCIETY INC. ("MSS") I HEREBY AGREE THAT:

1. I UNDERSTAND AND ACKNOWLEDGE THAT CAMPDRAFTING IS A DANGEROUS ACTIVITY AND MAY RESULT IN SERIOUS INJURY, PERMANENT DISABILITY OR DEATH.
2. I UNDERSTAND AND ACKNOWLEDGE THAT I RIDE AT MY OWN RISK
3. BY SIGNING THIS DOCUMENT I UNDERSTAND AND ACKNOWLEDGE THE RULES OF THE "MSS" AND AGREE TO BE BOUND BY THE CONSTITUTION, RULES, BY-LAWS, REGULATIONS AND POLICIES OF THE "MSS".
4. BY SIGNING THIS DOCUMENT I :
 - (A) WAIVE ALL OF MY LEGAL RIGHTS OF ACTION AGAINST THE "MSS" FROM ANY CLAIM, FOR LOSS, DAMAGE, INJURY, DEATH OR PERMANENT DISABILITY HOWSOEVER ARISING AND INCIDENTAL TO MYSELF (ORMY CHILD) ATTENDING AT AND/OR PARTICIPATING IN AN "MSS" ORGANISED EVENT. THIS WAIVER INCLUDES BUT IS NOT LIMITED TO LIABILITY FOR ANY NEGLEGENT OR TORTUOUS ACT OR MISSION, BREACH OF DUTY, BREACH OF CONTRACT OR BREACH OF STATUTORY DUTY ON THE PART OF THE "MSS" AND
 - (B) RELEASE THE "MSS" ITS ASSIGNS, ITS OFFICE BEARERS, EMPLOYEES OR AGENTS FROM ALL SUCH CLAIMS.

 - (A) I AM EIGHTEEN (18) YEARS OF AGE OR IF I AM UNDER EIGHTEEN (18) YEARS OF AGE MY PARENT OR GUARDIAN IS ALSO REQUIRED TO READ AND SIGN THE RELEASE.
 - (B) THAT MY SIGNATURE TO THIS DOCUMENT CONSTITUTES A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY OF THE "MSS" TO THE EXTENT PERMITTED BY LAW IN THE EVENT OF ME AND/OR THE CHILDREN UNDER MY CARE SUFFERING INJURY, DEATH OR PERMANENT DISABILITY.
